**Question 2: Should we prepare samples for tasting?**

Answer: Sample tasting is at the vendor's discretion.

**Question 3: I noticed that the district is requesting presentations at the time of the pre-bid. What are the requirements for this presentation?**

**Is the district looking to try food samples or are vendors expected to present service capabilities in addition to food samples?**

Answer: Food samples are at vendors discretion. Mexia ISD is looking for vendors to present service capabilities.

**Question 4: Can the district confirm that the summer feeding program is running for 10 days?**

Answer: The summer feeding program will run for a total of 30 operational days. (Summer school will be active for 10 out of those 30 days).

**Question 5: Will the district provide detail of what is included in the other federal reimbursement line in the amount of \$98,599?**

Answer: Per our FY 18-19 audit, this amount includes commodities and a vendor reimbursement of \$15,000

**Question 6: Will the district detail the SFA expense? Is that expense inclusive of the district labor cost?**

Answer: This is district labor costs.
