The district has modified the lunch periods and students are now spread out/socially-distanced throughout the building. As a result, additional staffing during lunch periods is needed to monitor the students and assist with meals. Desk shields/PPE for teaching staff and the nurses' office suite were also purchased for protection.

The district has implemented a cycle to support students in accelerating their learning and increasing momentum going into the 2021-22 school year. This process allows us to take a step by step look at our accelerated learning cycle and utilizes and identifies guiding questions and considerations for educators to help address learning acceleration. The Spartan Summer Escape is both an in-person and virtual program offering all of our students the ability to participate in all areas of academic enhancement/enrichment. The Kick Start program will address the SEL needs of our students and will address the stamina as well as the soft skill development that will allow students to feel confident and

A complete update of the district's long range facilities plan is needed to evaluate emergent needs relating to health & safety and security. Two sets of outside doors need replacement. Tech infrastructure update for safety and security, including firewalls, antivirus, switches, and wireless access points. Special education out of district tuition expenses. Central office staff member to coordinate social media & district messaging and keep community informed. Classroom unit ventilators, boilers, and rooftop cooling/split system replacement.

The district provides mental health support for students and staff through multiple modalities and programs. The district utilizes Response to Intervention/NJTSS, teacher referrals, and staff referrals to identify students who require socio-emotional support. In order to provide this support, the district employs two full-time guidance counselors and a new full-time school psychologist to provide individual counseling, group counseling, social skills groups, and targeted support groups based on students' needs throughout the year. The district also contracts with an outside agency to provide an additional social worker who provides individual and group counseling to students, and a behaviorist who
