RESOLUTION REGARDING ESTIMATED AMOUNTS

NECESSARY TO BE LEVIED FOR THE YEAR 2021

WHEREAS, <u>The Truth in Taxation Act requires that all taxing districts in the</u> <u>State of Illinois</u> determine the estimated amounts of taxes necessary to be levied for the year not less than twenty (20) days prior to the official adoption of the aggregate tax levy of the district; and

WHEREAS, if the estimated aggregate amount necessary to be levied, exclusive of election costs and debt service costs, exceeds 105% of the aggregate amount of property taxes extended or estimated to be extended, including any amount abated by the taxing district prior to such extension, upon the levy of the preceding year. A public notice shall be given and a public hearing shall be held on the district's intent to adopt a tax levy even though the amount is not more than 105% of the extension or estimated extension for the preceding year; and

WHEREAS, it is hereby determined that the estimated amount of taxes to be extended for the year 2021 Levy is as follows:

WHEREAS, the Truth in Taxation Act, as amended, requires that all taxing districts in the State of Illinois provide data in the Notice concerning the levies for debt service made pursuant to statute, referendum, resolution or agreement to retire principal or pay interest on bonds, notes and debentures or other financial instruments which evidence indebtedness; and

WHEREAS, the aggregate amount of property taxes extended for debt service purposes for 2020 was \$7,195,515.07 and it is hereby determined that the estimated amount of taxes to be levied for debt service purposes for 2021 is \$869,155.00.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education, Grayslake Community High School District 127, County of Lake, State of Illinois, as follows:

- Section 1: The aggregate amount of taxes estimated exclusive of debt service costs to be levied for the year 2021 is \$41,833,850.00
- Section 2: The aggregate amount of taxes estimated to be levied for the year 2021 does not exceed 105% of the taxes extended or estimated to be extended by the district in the year 2020.
- Section 3: The aggregate amount of taxes estimated to be levied for the year 2021 for debt service is a decrease of 87.92% of the taxes extended for debt service for 2020.

Section 4: Public notice shall be given in the Daily Herald, being a newspaper of general circulation in said district, and a public hearing shall be held, all in the matter and time prescribed in said notice, which notice shall be published not more than 14 days nor less than 7 days prior to said hearing, and shall be no less than 1/8 page in size, with no smaller than twelve (12) point type, enclosed in a black border not less than ¹/₄ inch wide and in substantially the following form:

- I. A public hearing to approve a proposed tax levy increase for Grayslake Community High School District #127 for 2021 will be held on November 11, 2021 at 6:45 p.m. at 400 North Lake Street, Room 1595, Grayslake, Illinois 60030. Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Abe Singh, Associate Superintendent, Grayslake Community High School District 127, 400 N. Lake Street, Grayslake, Illinois, 60030 (847) 986-3445.
- II. The corporate and special purpose property taxes extended or abated for 2020 were \$40,623,922.75. The proposed corporate and special purpose property taxes to be levied for 2021 are \$41,833,850.00. This represents a 2.978% increase over the previous year.
- III. The property taxes extended for debt service and public building commission leases for 2020 are \$7,195,515.07. The estimated property taxes to be levied for debt service and public building commission leases for 2021 are \$869,155.00. This represents a 87.92% decrease over the previous year.
- IV. The total property taxes extended or abated for 2020 were \$47,819,437.82.The estimated total property taxes to be levied for 2021 are \$42,703,005.00.This represents a 10.70% decrease over the previous year.
- V. The taxing district has estimated its equalized assessed valuation to secure new growth revenue and must adhere to the Property Tax Extension Limitation Law (PTELL or "tax cap" law). PTELL limits the increase over the prior year in the property tax extension of the taxing district to the lesser of 5.0% or the percentage increase in the Consumer Price Index (CPI), which is 1.4%.

Section 5: The resolution shall be in full force and effect forthwith upon its passage. ADOPTED this 11th day of November, 2021.
