School Parental Involvement Policy

The **Rivesville Elementary/Middle School** shall take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002):

 - WV's state and local assessments including alternate assessments
 - Requirements of Title 1 Part A
 - How to monitor their child's progress
 - How to work with educators
 - WVGSA Meeting held annually

8. The **Rivesville Elementary/Middle School** shall aid parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described:
