C. REPORTS

C.1.a. Administration/Status of Schools Superintendent Neil Cavallaro expressed how well the 1st extended day of school went. He informed the Board the high school graduation will be on June 15, 2021, at 4:00 p.m. He has discussed using both sides of the bleachers and maybe having the top 30 families on the field. There is a ticket maximum of 4 per family due to COVID. Neil advised that at the next Board Meeting he is going to have Marissa Acampora and Matt Cavallaro present the Board with a funding presentation. Additionally, Neil stated he sent out a letter regarding Distance Learning for next year and what the requirements would be. Neil thanked the Board and the Unions for the pizza truck and how successful it was.
