Also said paras are under paid for what they do. They do a great job but with that said leadership and management negotiated and its tough not to vote on it tonight but down the road their pay needs to be discussed. Patricia Libero stated I would like to give all staff a raise, but since we are under MARB, they certainly would not approve a huge raise. Our city is broke. Hopefully, next time we negotiate, we will be in a better position to offer raises to all!
