Patrick Egolum – I understand what Rose and Jimmy are saying but on the other hand if parents send their kids to school, I don't think it is a good idea to go against their wish. I think we should defer this decision to Neil whether to do in class or DL.

Cebi Waterfield – read a thank you note from Anne Druzolowski. It is a difficult decision that Neil has to make. I received emails from staff with their concerns but also parents that are concerned for their children's education.
