Superintendent Cavallaro spoke regarding contact tracing and staying with the four-hour session at least to the holidays. There is a lot going in a four-hour day with the elimination of lunch and recess. However, when does the Distance Learning end? The teacher's paras and secretaries are doing soluble work. We need to get kids by to school. I do not know if we can keep up the pace. I might know more after the Superintendent is meeting on Friday.

Rosemary Russo – how will you mange with all the students returning

Neil – it is going to be a challenge, but if schools are open, you have to come back. We do not have staff to do two jobs.

Rosemary Russo – with the money spent on Distance Learning there has to be a better way than 35% getting an hour teaching.

Neil – I am concerned about those students too. However, family that opt out are assuming the responsibility of teaching their children. There are a handful of kids coming back.

Rosemary Russo – The Commissioner of Education made it sound like we have people available.

Neil – we might use some of the teachers at home due to COVID. It would be based on the building needs. The State has to make a decision to get back to school.

James Morrissey – hoping the kids will get back. How is it going with the union and the administration? Take a deep breath it is for the students.

Neil – I have met with Kristen. We are giving a quality education.

Patrick Egolum- we need an incentive to send kids back to school. If teachers doing double work, is there any money in the budget for them?

Neil – I can't imagine a safer environment than what we provide. It is very safe. Teachers doing a great job keeping kids apart. We are looking into forming a Distance Learning team, which we are willing to pay extra. The principals are developing a plan.

Matthew Cavallaro reviewed the fiscal year 2021 operating budget and money spent through the CARES Act.
