As an educator, it has been extremely difficult to change our ways of teaching practically overnight. I have been impressed with work the teachers have put in; however, I do feel the district could be doing more to promote a sense of community. I'm extremely disappointed that my children have not seen their teachers faces at all during this time period, other than the videos the schools put together. I understand not all teachers are comfortable "meeting" students online, but it should be allowed if teachers wish to do so. The meetings do not have to be live—recordings are a great tool that can be used. With 3 children in the school system

they have not spoken to their teachers this entire time. They miss their teachers terribly and their teachers miss them. It is absolutely affecting the mental health of both parties. Several districts are allowing teachers to meet online or create recordings for their students—so why not West Haven? Is it the lack of training and resources? I'm very concerned that if school must continue distance learning next year that my children will become disengaged in school as they won't feel connected to anyone. This has already been a challenge this year. I love my children's teachers and support them in everything they do. I want my children's school district to support the option of allowing children to meet with their teachers and peers online. It is an educational inequity, especially when other local districts are already implementing this practice.
