## **New Business**

Incoming board members (Corey Moen, Tami Parker, Lynn Sand) signed the oath of office and were sworn in.

## The election of officers took place.

Aarsvold nominated Verwest as president. Verwest nominated Ogburn (Ogburn declined). Motion by Ogburn, second by Strand: that nominations cease and to cast a unanimous ballot. Verwest abstained from vote, motion carried. Mark Verwest will serve as president

Aarsvold nominated Strand as vice-president. Motion by Ogburn, second by Hovde that nominations cease and to cast a unanimous ballot. Strand abstained from vote, motion carried. Marlana Strand will serve as vice-president.

Business Manager, Kville presented the 2016-2017 business manager's report. Motion by Aarsvold, second by Strand to zero out the sport/activity accounts as presented. Motion carried.

Motion by Ogburn, second by Hovde to approve the business manager's report as presented. Motion carried.

Motion by Aarsvold, second by Hovde: to appoint Brudvik Law as the school's attorney. Motion carried. Administration will follow-up with Brudvik Law to make sure the same retainer and rates will apply.

Motion by Strand, second by Sand: to accept the 2017-2018 school board meeting schedule. Motion carried.

Motion by Hovde, second by Moen: to keep the board member the pay the same as last year. Motion carried.

Motion by Aarsvold, second by Hovde: to keep the bank depositores the same. Motion carried.

Motion by Hovde, second by Ogburn: to increase class fees by \$5 for grades 1-12. Motion carried.

Motion by Aarsvold, second by Strand: to increase lunch prices as presented. Motion carried.

Student lunches from \$2.50 to \$2.75 Breakfast from \$1.70 to \$1.75 Adult lunches from \$3.25 to \$3.50

Motion by Aarsvold, second by Sand: to increase Activity Fees as presented. Motion carried.

Grades 9-12 from \$45 to \$75 per activity; reduced rate from \$18 to \$35

Grades 7-8 from \$35 to \$50 per activity; reduced rate from \$15 to \$25

Grades 7-8 (all spring sports) to \$25; reduced from \$7 to \$10

The maximum fee charged any one family PER SEASON will be \$150

Motion by Hovde, second by Moen: to increase Adult Activity Tickets to \$75 for single, \$125 for a couple. Motion carried.

Motion by Ogburn, second by Hovde: to follow the state rate for mileage reimbursement. Motion carried.
