PROCEDURE FOR PARENT INVOLVEMENT POLICY

The following procedures shall be used to carry out the district's policy regarding parent involvement.

- 1. White Pass School District will involve parents in the joint development of its district-wide parental involvement policy by establishing a district-wide parent advisory council to provide an opportunity for input on matters related to parental involvement in Title I, Part A programs.
- 2. White Pass School District will involve the Parent Advisory Council in the process of school review and improvement by:
 - A. Convening a meeting in the fall to review assessment data.
 - B. Convening a meeting in the spring to review the results of parent surveys and review the previous year's policy and progress.
- 3. White Pass School District will provide necessary coordination, technical assistance, and other support to assist Title I, Part A schools in planning and implementing effective parental involvement activities to improve student academic achievement by:
 - A. Making facilities available for parent activities including, but not limited to:
 Open House, Christmas Program, Science Fair, PTO meetings and activities, building
 level Title I planning meetings, parent-teacher conferences, Strengthening Families,
 Relatives Raising Others, READY! For K, Books and Blankets, Evenings of
 Excellence, Teen Nights, Family Nights, TAP (Team Academic Planning) meetings,
 Evening Among the Stars (WASL celebrations), Family Math Nights (WASL

 - D. Ensuring that information related to the school, student achievement, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable format.
 - E. Recruiting, encouraging, supporting, and honoring parent volunteers in the buildings.
