Total Allocations as of April 1, 2022 is \$33,440,761.82.

Annual Congressional audits will be conducted each July 1 – September 30 through 2024.

In September 2024, districts will be required to explain expenditures for our budgeted allocations which includes safety, addressing learning gaps, continuity of operations, and being stronger and better school systems.
