HB 17-1375 Charter School/Mill-Levy: HB 17-1375 is written for sharing mill levy override dollars with charter schools inside district boundaries.

WHEREAS, in 2017, the Colorado General Assembly adopted House Bill 1375, codified at C.R.S. § 22-32-108.5 ("H.B. 17-1375"), providing that for the 2019-2020 budget year and for each budget year thereafter, a local board of education of a participating school district shall either (i) distribute to each charter school or innovation school of the district 95% of its district per pupil mill levy share multiplied by the number of students enrolled in each charter school or innovation school, or (ii) by July 1, 2018 adopt and then implement in budget year 2019-2010 a plan for equitably distributing its additional mill levy revenue to support all students, regardless of what type of school in which they are enrolled; and

WHEREAS, a "Participating School District" is defined in C.R.S. § 22-32-108.5(2)(f) as a school district that, on or after June 2, 2017: (i) collects additional mill levy revenue; and (ii) is designated as a school district of innovation as provided in C.R.S. § 22-32.5-101, et seq. or authorizes at least one charter school as provided in C.R.S. § 22-30.5-101, et seq.; and

WHEREAS, Byers School District ("District") does not currently collect additional mill levy revenue; and

WHEREAS, the District has not authorized any charter schools (except for multi-district online schools pursuant to C.R.S. §§ 22-30.7-101 to -113) and is not a district of innovation; and

WHEREAS, the District's Board of Education ("Board") believes that, even though it currently does not qualify as a Participating School District under H.B. 17-1375, in order to meet the needs of and equitably support the education of all students enrolled in the District, it is necessary to adopt a Plan that will be in effect at such time in the future that it does become a Participating School District.

NOW THEREFORE, BE IT RESOLVED by the Board of Education of Byers School District that although it is not currently a "Participating School District" as defined in H.B. 17-1375, to the extent that it would qualify in the future, it believes it to be in the best interest of the District to adopt, and it does hereby adopt, a mill levy sharing plan that, absent future revision by the Board which authority is hereby reserved, will allocate 95% of the District's per pupil mill levy share for the applicable budget year multiplied by the number of students enrolled in any district charter school and/or innovation school for the applicable budget year on or after 2019-2020.

BE IT FURTHER RESOLVED that the Board shall periodically review its H.B. 17-1375 Plan and update it as necessary to ensure that if additional mill levy revenue is collected by the District, it will be equitably distributed as provided in C.R.S. § 22-32-108.5(4)(a) to (4)(c) to the schools of the District to benefit all of the students enrolled in all of the schools of the District.

BE IT FINALLY RESOLVED that if a future ballot measure for additional mill levy revenue is passed in the District by voters, the use of that revenue shall be controlled by any ballot language restrictions that are voter approved. In the event there are no restrictions on the use of those additional mill levy revenues for any such future ballot questions, then the District shall calculate the allocation for each charter school in the same manner as above or as otherwise required in the event a new charter school or an innovation school is approved by the Board.

Mr. Tucker moved, Mr. Bauer seconded to approve the resolution for HB 17-1375.
