They also asked Mr. Turrell to have them add the concrete work that needed to be done at the baseball field.

Mr. Turrell noted that conversations are being had with Great Plains Academy to determine the funding so that works for both parties. The way the formula runs through neither Byers or GPA is getting the funding they originally anticipated.

Mr. Turrell asked the Board about the Multi-Purpose Field. In order for it to drain properly, material is needed to bring it up level. A community member is willing to donate the material. He is only asking for the cost of fuel and his laborers. It was suggested that cuts be made in the concrete which would also create better drainage. Mr. Turrell will further discuss with the building and grounds committee to determine the best solution.
