A RESOLUTION OFFICIALLY CERTIFYING THE LEVY OF THE BYERS SCHOOL DISTRICT 32J FOR THE CALENDAR YEAR BEGINNING JANUARY 1, 2021

(1/2 Fiscal Year 2020-2021 and 1/2 fiscal year 2021-2022) TO THE BOARD OF COUNTY COMMISSIONERS

WHEREAS, Section 39-5-128 (1), C.R.S. requires that BYERS SCHOOL DISTRICT 32J certify its 2021 levy to the Board of County Commissioners of ADAMS & ARAPAHOE COUNTIES no later than December 15; and

WHEREAS, Section 39-10-114 (I) (a) (I) (B), CR.S. which authorizes school districts to certify an Abatement and Refund Mill Levy in order to recover abatement of taxes.
