K-8 gym building and site ADA upgrades

- Metal building almost done with engineering.

HS Re-roof

- Was designed and bid last fall but was delayed due to materials procurement and winter weather.

- K-8 gym/cafeteria/kitchen is scheduled for summer 2022 and summer 2023.

- HS HVAC upgrades.
- HS Classroom re-purposing to accomplish all classrooms on upper floor.
- Modular removal and moving math & counseling into the main building.

7. INFORMATIONAL

- - High school basketball winter awards will be held on March 30th.
 - Six baseball players are playing with Dufur
 - Basketball summary:

We had a very successful year. The HS girls team had a 15-8 record. They missed going to state by one game. HS boys had a 25-1 record. They were district champions and 2nd in state. This was the most games the boys have one in school history. A special thank you to everyone that came and supported both teams. There were many people in the send offs and send ins.

• Track summary:

Practice will start for HS tomorrow. We are hoping to have district track in Maupin this spring. Junior high track will begin after spring break. They will practice 4 days a week.

• STEM Report:

Last weekend the team went to the state championships in Hillsboro. Regional was held in Gladstone. There are 372 STEM teams in the whole state. The South Wasco team was in the top 10% of the state. Students from SWC complete with much larger schools and are not divided into leagues based on school size, so students are completing with all various sizes of schools. This year 66% of the STEM club were 1st year participants. VEY robotic sets for K-12 were purchased thru a CGEDS grant. The STEM club will start presenting and working with the grade school with these kits. It was a very exciting season. Thank you to Mark Endsley and two board members for attending the state tournament. Thank you also for the community support that cheered the team back from state by the roadways in The Dalles, Tygh Valley, at the junction and Maupin.

- - Met with high school seniors that are at risk of not graduating and have plans set up

for all of them thru credit recovery, GED, or taking an additional year at the high school.

- Followed up on some HS seniors that have attendance occurrences.
- On time graduation advising for the Junior class was completed.
- District received a CTE grant for \$36,000 for equipment, which will build on the
 emerging plan for engineering CTE programs. Working with CGCC and providing
 release time for teachers to meet with other district teachers to share practices in the
 CTE program.
- Community outreach dinners have been planned for 8th grade parents. Two will be in Maupin, one at the Wamic grange, and one at Simnasho. Dates for the dinners are posted on the school web page.
- The school had elementary, JH, and HS OBOB teams. The state tournament was cancelled and OBOB coaches from the area are trying to organize a regional competition.
- C. Superintendent's Report......Ryan Wraught
 - HS hosted watch parties for the community to see the basketball game on the large blow up screen in the gym. There was a good turnout. The first game had about 50 people and second game had around 82 in attendance. Thank you to the kitchen staff who made food and refreshments without being asked.
 - Six kids will be participating in the Summer trades program with Dufur. A coordinator from Dufur will visit with students. This is with Baker Technical Institute.
 - Applied for a seismic grant which has a potential of a \$2.5 million grant award.
