The district reached out to stakeholders in a variety of ways over the past year through the LCAP and Expanded Learning Opportunity Process. First, the district sent out surveys to understand the needs of our families and students. The district then scheduled zoom meetings for each stakeholder group. During the Expanded Learning Opportunity Process, stakeholders (Students, Families that speak languages other than English, School and District Administrators, Special Education Administrators, Teachers, School Staff, and Local Bargaining Units) gave their input on learning supports to address learning loss, supplemental instructions and support strategies, and mental health needs. The LCAP stakeholder input focused on addressing ELA and mathematics data and finding strategies to address issues, school climate, student absenteeism during COVID-19, addressing Learning Loss, strategies for safe in-person learning, and pupil and family engagement and outreach. Additionally, during each staff and parent advisory meeting participants were encouraged to give their input on what is working, what is not working. Most recently the district asked parent groups the following questions to ensure continuous improvement and communication with parents: What should we continue doing? What should we stor doing? What should we start doing?

Lost Hills Union School District evaluated its stakeholder engagement opportunities and determined that Civil Rights Groups, Tribes, and Advocates are neither present nor serve the LEA.

Stakeholder meeting input and survey results were summarized and included in needs assessment data. Based on this data, the district will focus on aligning/ complementing actions and services already inplace through the LCAP and Expanded Learning Plan. For example, the district will expand all supplemental programs, Afterschool Program, Saturday Academy, and Saturday School in order to serve more students in smaller group settings. During the regular school day, we will focus on providing additional paraprofessional support to all students, maintaining smaller class sizes in grades K- 2nd, and ensuring each student has access to his/her own device.
