SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. The district will use funds to offer a one-time stipend of \$1,500 to all school employees who obtain the Covid-19 vaccine in order to safely operate our school for in-person learning consistent with the most recent CDC guidance on reopening schools. Being vaccinated will prevent staff from being quarantined when exposed to a covid positive person, thus mitigating the chances of lost instructional time due to their absence from the classroom. Further, having staff that are full vaccinated will serve as another protective measure for our children.

The district will appropriate up to \$1,500 stipends to staff for increased workload duties caused by the conditions of Covid-19 in years 2 and 3 of the grant period.

The district is experiencing a high degree of absenteeism of staff due to quarantine, illness and mental health concerns. Funds will be used to hire 2 full-time, certified substitute teachers to ensure continuity of learning.

The district will upcycle an existing school bus to provide students, staff, and community members with a mobile resource that promotes educational opportunities and community events through science, technology and makerspace activities.

The impact of the pandemic on K–12 student learning was significant. The pandemic has resulted in many of our students missing out on crucial learning opportunities that support early literacy development, which is essential for reading success. The additional elementary school teachers will reduce class size thereby increasing student to teacher contact time for meaningful interactions and intervention. Remote learning has caused additional setbacks for our low-income students and minorities, as well as students with disabilities. Students were moved on to the next grade unprepared and missing key building blocks of knowledge that are necessary for reading success. Given the major strides young children typically make in mastering reading, early reading development and skills are critically important for later academic success, this is of particular concern for our students. The *LETRS*® professional development provides teachers with the knowledge they need in order to begin the process to “close the gap” on student achievement and provide students with a solid foundation for learning early literacy skills through systematic instruction.

The best place for children to be is in the classroom in front of their teachers. Incentivizing staff to be vaccinated against Covid-19 is the best way to ensure that students will maximize the amount of contact time with their teachers and service providers, have access to meals, and important social opportunities that are present in a school setting which contribute to a students' positive mental health.

The district will contract with Questar III BOCES to provide job-embedded coaching opportunities in the areas of ELA and Math, and explicit instruction in special education to address learning loss and enhance focus on struggling learners.
