Karen Maynard greeted the Board and noted that she was pleased to see the District's school visitors policy reverted back to the previous policy prior to the pandemic. Ms. Maynard then stated her concern was that the policy seemed to be different at every school and asked that District administration address the discrepancies so that parents can visit their student's school.

## **Certified P.P.C. Presentation**

Ms. Robinson, PPC Certified Chairperson, greeted the Board and wished a Happy International Women's Day to all the women in attendance. She stated that March 14 was the last day of the 3rd quarter and that students and teachers, alike, were excited about the upcoming Spring Break. Ms. Robinson added that the ACT Aspire assessment was the next major task. She shared that the MAP scores were increasing and that identified teachers were celebrated within the schools and on the District's facebook page for their accomplishments in increasing their students MAP scores. Ms. Robinson expressed that teacher morale is a top priority for the PPC Committee and District administration and that a survey would be sent to teachers to gather feedback on their experience/needs so that teachers are supported and empowered in doing their job. She continued by saying that Teachers are still Heroes in this ongoing pandemic. Ms. Robinson ended her comments by stating that updated policies would be presented to the Board by April and that the Committee and District administration are working through any issues.

## **Comments from the Board**

Dr. McNulty shared that it had been two years since the Coronavirus pandemic started when chromebooks and packets were being disseminated to all students as District schools were shut down and he couldn't be prouder and happier of the great work the District's professional staff and students have done with dramatic outcomes and growth in the 96/97th percentile. He gave a shout out to the Board: Ms. Ward and the great turnout at College Station Elementary and the Maumelle Police Department in securing area schools while responding to an incident. Dr. McNulty then expressed his appreciation to the parents and the Communications Department under the direction of Ms. Duff.
