

Snowflake Junior high School Student Retention and Summer School

Summer School Criteria

Criteria are based on grades from Core Class Subjects -ELA, Math, Social Studies, and Science

- Students with a total of 2 Semester "F's" in <u>any combination of core subjects</u> will be considered for Summer School unless the student was able to show proficiency in the summer school test that was given.
- Students with a total of 3 Semester "F's" in <u>any combination of core subjects</u> **MUST** attend Summer School.

Summer School Contract with Parents, Students, and Teachers

The Summer School Contract Agreement between the Parents, Students, and Teachers will include, but is not limited to the following:

1. Absence Policy

- More than 2 excused or unexcused absences (i.e. vacations, camps, treks, etc) will result in dismissal from Summer School and retention.
- o 3 Tardies equals one absence.

2. Tardy Policy

 1-19 minutes late is considered tardy. 20 minutes late will be considered an absence. This is not per class period but for the entire day.

3. Passing Standards

- Students scoring below 60% in a class/subject will not receive credit and will be considered for retention. The grading policy will not be based on participation but on proficiency scores and ability.
- 4. Violation of the Snowflake Junior High School Discipline Code of Conduct will result in the student being sent home for the day, and it will be considered an absence.
 - A poor attitude towards work, teacher, or fellow students will be considered an infraction of the Summer School discipline policy.

- 5. Major infractions that will result in immediate release from Summer School and consideration for retention include, but are not limited to the following:
 - o Assault
 - Defiance(major)
 - o Drug/Tobacco/Weapon Possession or Use
 - Fighting
 - o Vandalism
 - o Harassment/Intimidation/Bullying
 - Verbal Abuse of Staff
- 6. In-class work vs. no homework policy
 - Homework will not be assigned. Students should be able to finish the assigned work during class. However, if a student fails to utilize the time given they may have work to complete at home. If a teacher feels additional practice needs to be completed in order to get to grade-level mastery it is encouraged.

7. Signatures

- Parents are required to sign the Summer School Contract or the student will forfeit the Summer School opportunity and will automatically be retained.
- Students must also sign the Summer School Contract.
- By signing the contract, both the parents and student agree to the Summer School Contract.
- 8. Students must pay to attend Summer School. The cost per student is \$100.00
- 9. Transportation and food services are not available for Summer School students.
- 10. Summer School begins May 31, 2022, and ends June 23, 2022.
