Parents were invited to respond to a survey during the week of April 26th to May 2nd. Subsequently, parents were invited to participate in a Zoom meeting to discuss survey and assessment data as well as proposed goals and actions on May 6, 2021.

All staff, which includes both certificated and classified bargaining units, were sent a survey on April 20th. School-wide and subgroup assessment data was distributed to all staff and discussions concerning the implications of the data were held in bi-weekly staff meetings throughout March and April. On May 4, 2021 certificated and classified staff reviewed previous LCAP Goals and Actions and made recommendations. Some of these recommendations will be used in the ESSER III Expenditure Plan.

Students received a survey during the week of April 26 - 30.

We presented student data to site council in April and solicited input.

Administration consulted the SELPA in March.

Survey results reveal that parents, students and staff believe Butteville School is doing an excellent job. Concerns over learning loss during the 20/21 school year were expressed by both parents and staff. Staff also expressed safety on campus concerns and needs.

## A description of how the development of the plan was influenced by community input.

Parents continue to be pleased with the overall performance of Butteville School.

82% of respondents stated teachers respond to concerns quickly.

90% stated their child is treated respectfully by staff.

96% stated their students feel safe at school.

84% said the facilities are clean.

73% stated that students treat each other respectfully.

75% said their students are excited to be at Butteville Elementary.

These results are consistent with previous years results.

18 staff members, both certificated and classified, responded to their survey. Staff survey results show that:

91% state they are treated respectfully by other staff members.

95% believe they work well with students.

89% state they love working at Butteville School.

Discussions with teachers concerning student achievement, goals and possible actions were held during bi-weekly staff meeting from March through May. Teachers expressed a desire to have a wide variety of courses available for students beyond the core curriculum such as art, music, gardening and dance. They also expressed that our facilities were clean and safe but that there were some maintenance projects that should be addressed such as the condition of the outdoor basketball courts, classroom windows, additional exit doors, carpet, and lack of storage. After reviewing data for the 20/21 school year staff and parents stated they felt there was a need for additional instructional aides and an expanded RtI program.

Parents and staff expressed concern for student mental health after the trying pandemic year. The school will contract for a mental health counselor to help students who are experiencing difficulties.

Classified staff discussed student achievement at monthly staff meetings. They were provided copies of historical as well as more recent achievement data during meetings. They expressed concerns that more instructional aides were needed to assist under-performing students make progress.

Students were surveyed during the week of April 26-30. A review of survey results show that:

90% believe they are receiving a good education

75% believe they have a staff member they can talk to if they have a problem

91% believe they are safe at school

85% believe teachers have high expectation of their work.
