Dear Board and Administration -

It has come to my attention that an omission appears to exist in the April 2023 regular board meeting minutes. This meeting was attended by DPEA members Kathy De Marco and Laurie Lapan. Kathy and Laurie recall during the Superintendent's Report regarding classified staff contracts for 2023 -2024, Cindy Barnes explained that Tana Anderson, Samantha Marcus, and Rachel Younger's contracts would not be voted on, due to Tana and Sam's relation to a board member and Rachel's relation to a potential board member (addressing Mike Younger, who was present at the April meeting). The vote for their 2023-2024 contracts would require a meeting with public notice and all board members present. The April minutes do not reflect this clarification.

In addition, as of June 9th 2023, when visiting the Deer Park website and clicking on the link for the April 11th, 2023 regular board meeting agenda, the correct document is not posted. The link instead takes the reader to the May 9th reorganization board meeting agenda.
