Section 551.076	To discuss the deployment, or specific occasions for implementation of security personnel or devices;
Section 551.082	To deliberate in closed meeting in a case:
	(a) Involving discipline of a public school child; or
	(b) In which a complaint or charge is brought against an employee of the school district by another employee and the complaint or charge directly results in a need for a hearing;
	(c) The school district may not deliberate in closed meeting if an open hearing is requested in writing
	by a parent or guardian of the child in discipline cases, or by the employee against whom the complaint or charge is brought. The employee making the charge has no say whether the hearing is open or closed
Section 551.084	To exclude a witness from a hearing during the examination of another witness in the investigation;

Should any final action, final decision, or final vote be required in the opinion of the governing body with regard to any matter considered in such closed meeting, then such final action, final decision, or final vote shall be at either:

(a) the open meeting covered by this notice upon the re-convening of this public meeting; or
