Elementary Happenings

What the students are doing...

- The Summer Learning Program is well under way, with over 30 students attending on a regular basis. Although the program is designed to prevent significant regression in academic achievement that is typical over the summer months, there has been time to include some engaging STEM and team building activities.
- Cornell Cooperative Extension has expanded their Summer Camp *Full STEAM Ahead* to include students entering 5th grade. The camp will take place August 6th-10th at Beaver River Central School and transportation will be offered.
- Summer school students are tending the school garden, learning about different types of plants, and just how much hard work goes into growing food.

What the adults are doing...

- A variety of summer professional development opportunities have been made possible through the Knights in Training, Knights' Armour and Wee Knights grants. Teachers have attended the P-3 conference hosted by the Office of Early Learning in Albany (where the focus was on using play as an instructional strategy), signed up to develop science curriculum, planned to work on updating the RTI plan, continued work on the PBIS process, and have been invited to learn more about instructional resources embedded in STAR Math.
- Schedules for our special education students are a work in progress as we try to match the needs of students with the strengths of our teachers.
- The Leadership Conference held in Lake Placid July 12th 14th was once again fabulous. One great take away was Michael Hyne's understanding of our purpose to educate the whole child. His belief is that physical growth, emotional growth, academic growth and social growth (PEAS) are all equally important.
- Mrs. O'Shaughnessy and I are to act as judges for the Spelling Bee at the Lewis County Fair on Friday.
- End of the year reports and applications for the upcoming school year have been completed for both our three year old and four year old prekindergarten programs.

 - Students who cannot pay for a meal or who have unpaid meal debt shall not be publicly identified or stigmatized (including wristbands or hand stamps), required to do chores or work to pay for meals, or have meals thrown away after they have been served. District staff shall not discuss a student's unpaid meal debt in front of other students. The district shall not take any action directed at a student to collect unpaid school meal fees. However, the district may discreetly notify students of their account balances, and why certain items (e.g., à la carte, etc.) could not be provided with charged meals.
