All individuals on the Nation two (2) years of age and older shall wear masks while in public (any area outside your home where you could come within 6 feet of someone who is not from your household). (Public Health Emergency Order No. 2021-015, August 4, 2021)
		Teachers regularly instruct students on proper mask wearing and fitment.
Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)	Y	Policy requires that classrooms and school capacity will be determined based upon the physical distancing recommendations made by the CDC, the AZ Dept of Health, and the Navajo Nation Health Dept. Classroom seating shall accommodate 3 ft. spacing between students, and at least 6 ft. physical distancing when possible.  Excess furniture and clutter will be removed and stored in the surplus warehouse to maximize available space.  Written procedures provide guidance for power outages. Power outages cause ventilation to stop so procedures are in place.
Handwashing and respiratory etiquette	Y	Policy requires signage in all classrooms, schools' common areas, buses, cafeterias, reminding students and employees of the proper handwashing etiquette and respiratory etiquette. Hand sanitizers are placed at each classroom entrance, cafeteria entrance, restroom entrance, hallways, school common areas and buses. Teachers regularly teach and instruct students of proper hand sanitizing and covering of cough and sneezes, NO spitting, and physical distancing.

		The district does offer the alternative of allowing

#### **How the LEA will Ensure Continuity of Services?**

SY 22-23 the district will offer in-person learning. Virtual learning will be an option for students that may be in isolation or quarantine due to being positive for COVID-19 or family exposure. Parents that may insist on virtual or



online learning will be encouraged to enroll in readily available Arizona Online Instruction (AOI) programs or other online learning options such as Primavera or ASU Prep Digital Learning.

Social, Emotional and Mental Health Needs	Priority and continuity of services.  KUSD has adopted and will implement the Beyond Textbooks curriculum framework for grades k-12.  The Multi-tiered System of Support (MTSS) framework will be implemented for all students with academic needs.  The Professional Learning Community process will guide school improvement.  Professional development on assessment, differentiated instruction, and curriculum development is provided regularly. The governing board has approved off-contract time for SY 22-23 for teachers to participate in training.  Assessments include screeners and diagnostics (ELA, ESS, and Math) to identify the learning needs of students; regular benchmark assessments are used to determine the effectiveness of instruction and learning.  Reteach and Enrichment learning opportunities are built into the daily schedule or week.  Grades k-5 classrooms will continue to have new personnel (teaching assistants) to assist with learning  EL programs have been enhanced with two additional support staff to assist with coordination of EL services and three full time EL teachers.  The Multi-tiered System of Support (MTSS) framework will be implemented for all students with behavioral needs.  The Restorative Practices in Schools Implementation and Training will provide opportunity to leadership groups and subsequently all teachers. (Restorative Solutions)  Continuity of Services in SEL:  All employees will have refresher professional development with "The Good Road of Life" by Native Hope. The emphasis being empathy, respect, trust, and patience.  Native Hope and VOICE provides seminars for students with high risk factors and high needs. Grade 7-12.  Continuing and enhancing the use of strategies learned in Capturing Kid's Heart program are ongoing

Preliminary indications and draft plans support opening in-person for all students with an option to enroll students in virtual opportunities as the families wish. ## **U.S. Department of Education Interim Final Rule (IFR)**

#### (1) LEA Plan for Safe Return to In-Person Instruction and Continuity of Services

- (a) An LEA must describe in its plan under section 2001(i)(1) of the ARP Act for the safe return to in-person instruction and continuity of services—
  - (i) how it will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policies, on each of the following safety recommendations established by the CDC:
    - (A) Universal and correct wearing of masks.
    - (B) Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)
    - (C) Handwashing and respiratory etiquette.
    - (D) Cleaning and maintaining healthy facilities, including improving ventilation.
    - (E) Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments.
    - (F) Diagnostic and screening testing.
    - (G) Efforts to provide vaccinations to school communities.
    - (H) Appropriate accommodations for children with disabilities with respect to health and safety policies.
    - (I) Coordination with State and local health officials.
  - (ii) how it will ensure continuity of services, including but not limited to services to address students' academic needs and students' and staff social, emotional, mental health, and other needs, which may include student health and food services.



(b)(i) During the period of the ARP ESSER award established in section Start Printed Page 212022001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.

- (ii) In determining whether revisions are necessary, and in making any revisions, the LEA must seek public input and take such input into account
- (iii) If at the time the LEA revises its plan the CDC has updated its guidance on reopening schools, the revised plan must address the extent to which the LEA has adopted policies, and describe any such policies, for each of the updated safety recommendations.

  - (iii) Upon request by a parent who is an individual with a disability as defined by the ADA, provided in an alternative format accessible to that parent
