Anonymous "swatting calls" have occurred in Mahaska and Wapello counties today. The district has been contacted by each county's sheriff department. Wapello county called the high school to provide EBF a heads up. Mahaska County visited Eddyville Elementary to communicate directly with the administrator.

Mahaska County also visited the Fremont school building because of a call they received of an event at Fremont. The threats thus far have been determined not to be credible.


The anonymous "swatting calls" are being made today to law enforcement agencies across the nation, including our district, making threats to schools.

"Swatting calls" are calls made to law enforcement or directly to schools, businesses, public libraries, or other entities where the public gathers. These calls are an attempt to trigger the dispatch of emergency services to a particular address.

EBF is operating under normal operations and learning is continuing as scheduled. All administrators are aware of the situation occurring across our state and nation.

A safe learning environment for our students and staff is a priority.
