In addition, some positions are extended beyond the normal 191 day contract and some positions receive stipends or salary supplements for extra duties. A list of positions receiving extended contracts and salary supplements is attached. For such positions, total contract is computed as follows:

- (1) Find the employee's position on the payscale based on his/her level of education and years experience.
- (2) Divide that amount by 191 days and multiply by the number of days in the extended contract. For 12 month contracts, an average 240 days is used.
- (3) To that amount, add any stipends which apply.

Other Fringe Benefits: (1) All contracted employees who work 30 hours per week or more receive employer provided dental insurance. (2) All contracted employees who work 30 hours per week or more are eligible to participate in employer sponsored group health insurance. (3) All contracted employees are eligible to participate in employer sponsored IRS Section 125 Fringe Benefits "Cafeteria Plan." (4) A 14% matching expense for membership in the Arkansas Teacher Retirement System (ATRS) is paid by the employer. (5) ATRS member employees may repurchase lost years of service from ATRS and/or may convert previous non-contributory years to contributory via payroll on a tax deferred basis. (6) Other fringe benefits per policy.
