The 2018-2019 Schoolwide Improvement Plan and the Title I agreement will be available for review and input at Fall Parent Conferences (both documents are updated annually on our district web-site for parent/guardian review). The Davis Elementary School-Parent-Student Agreement (Compact) is distributed and conferenced on with each student and parent during fall parent teacher conferences. Davis will continue goal setting conferences during the 2018-2019 school year. The staff also wants to continue to provide training for the parents on reading and math strategies to use at home to improve student achievement. Annual Doughnuts with Dad (October 2018), Goodies for Grandparents (February 2019), and Mornings with Mom (May 2019) activities builds positive parent-school-community relationships. We will utilize the morning events to survey our community members in order to seek up to date feedback on our school progress. A "Meet Your Teacher" event will be held prior to the first day of school will occur in late-August 2018. Each May kindergarten teachers conduct an evening event to provide new families information and materials to work with their children prior to kindergarten.

The October conference teachers and students set and present goals to their parents. Teachers will present parents with recommended methods of helping in math and reading at home. As a staff, we will strive to encourage literacy/math and establish support for classroom expectations. Information about the Common Core State Standards and SBA testing will be provided throughout the year. We will continue to provide written documents as the most prominent means of providing parents and other stakeholders with information. Digital versions will also be available as applicable. All key documents are translated into Spanish.

Personal Contacts: Connecting with parents and guardians is viewed by the district as being the most effective means of sharing and receiving parent information. Parents are welcome and encouraged to make contact with staff and administration. Following are methods and strategies of communication:

- The district's phone system is designed for both English and Spanish speaking callers.
- Formal "Parent-Teacher Conference" days are scheduled into the District Calendar. Translation will be available for staff members. Conferences are scheduled to accommodate the work hours of parents and are flexible enough to allow for meetings that must occur outside the identified days. Conferences will be held at Davis and at Valle Lindo to accommodate parents.
- Parent advisory team will meet periodically throughout the year to discuss concerns, reflect on progress and to adjust plans for the betterment of Davis Elementary.
- Parent and community meetings are typically held during the evening hours to accommodate the working schedules of most adults. Translators are provided at parent meetings when it is known that Spanish-speaking adults may be present.
- Morning events such as goodies with grandparents will be utilized for building relationships and checking on school improvement through survey questions.
- Evening events such as Science Night will allow more face to face communication time between staff and families. Events such as these also provide community members a time to respond to specific questions created towards our goals.

Davis Elementary School is committed to the goal of providing quality education for every child in this district. To this end, we want to establish partnerships with parents and with the community. Everyone gains when teachers and families work together to promote high achievement. Parents and families play an extremely important role as children's first teachers. Support for their children and for the school is critical to children's success at every step along the way. Davis Elementary recognizes that some students may need the extra assistance available through the Title I program to reach the state's high academic standards. Davis Elementary intends to include parents in all aspects of the school's Title I program. The goal is a school-home partnership that will help all students to succeed.
