## SAC Minutes – December 12, 2022

### Attendance:

### Call to Order:

A meeting of the Hardee Junior High School Advisory Council was held in the room 305 on December 16, 2022. Principal, Dr. Sheryl Mosley called the meeting to order at 3:46pm.

**Minutes:** Reviewed minutes from the first meeting held on October 17, 2022. Mrs. Calvillo motioned to approve minutes and Mrs. Rivas seconded it.

### New Business:

1. **Welcome:** Dr. Mosley opened the meeting by welcoming everyone back. Each member was given a copy of the HJH SAC minutes from the last meeting (October 17, 2022) to review. Dr. Mosley asked if anyone had additional questions about the SAC minutes. No questions were asked. Mrs. Calvillo motioned to approve minutes and Mrs. Rivas seconded it.
2. **School Improvement Plan:** The SIP has been approved by the Hardee County School Board. The SIP is considered a working document and can be worked upon during the year. Dr. Mosley shared data comparing FAST Pm#1 to PM#2. There are still several students that were absent and had to makeup either reading or math. Reading School wide percent on target (Level 3 or higher) went from 32% to 33% from PM#1 to PM#2. Math school wide percent on target (Level 3 or higher) went from 13% in PM#1 to 25% in Pm#2. Our final FAST test will be administered sometime in May.
3. **Parent and Family Engagement Plan:** Our next parent night will be held on December 19, 2022 (Christmas around the World). Teachers and students will learn how other countries around the world celebrate Christmas. Each Pod will select a country of their choice and learn their Christmas traditions. Parents will be encouraged to walk around HJH halls and discover the magic of Christmas around the World. Parents will be given a passport that will be stamped as they travel to various countries. We will have a special guest arriving from the North Pole. Parents and students will be invited to watch a Christmas movie in the commons. Ms. Bryan and her advanced band will also be performing for parents starting at 7:00 in the auditorium.
4. **SAC Officer Elections:** Dr. Mosley decided that we needed to nominate a new President Chairperson and Vice-Chairperson. Those parents are no longer parents of HJH students. The Secretary (Linda Calvillo) would remain in current position. Laura Galvin nominated Hilaria Cuevas for president and Mrs. Calvillo second it. Beckie Johnson nominated Laura Galvin for Vice-Chairperson and Mrs. Calvillo second it.
5. **Title I 6150:** (Parent Involvement Funds) - Dr. Mosley explained that these funds are used to promote parent involvement and encourage student achievement. Currently there are \$4,245.00 in the account. Mrs. Rivas motioned to approve the funds being used for parent

involvement such as Christmas around the World parent Night and Literacy Night. Mrs. Calvillo second it.
