- 1. Kristain Dedmon called the meeting to order at 6:00 p.m.
- 2. Ollie Collins offered the invocation.
- 3. Samantha Tippy called the roll and a quorum was declared.
- 4. The Board recited the District Vision and Mission statement. Motion made by Torian Bell, seconded by Ollie Collins to approve the February Meeting Minutes with the adjustment. Motion passed 6-0.

- 5. Richard Ford presented the Siemens Energy Savings Update. Mr. Ford stated that the savings for phase one of the project has saved 5% over the last 6 years. He stated phase one is the High School campus, North Elementary, and Middle School. Phase two has saved 2%.
- 6. Dr. Green presented a list of Fixed Assets that need to be removed from the District's inventory list. Some of these materials date back to the 1980s. Mrs. Dedmon asked if we sell them.
