- 8. Dr. Dedmon presented the List of Bills. Jacqueline Baker requested a better description on the list of bills for mileage/reimbursements. Jacqueline Baker made a motion to pay the bills. Ollie Collins seconded the motion. Motion passed 5-0.
- 9. Worker's Compensation Insurance Dr. Green presented the ABSA Workman's Comp invoice. The invoice was \$25,756.00. This rate is higher due to the amount of claims we have had the previous year. Dr. Green asked for a motion to approve the invoice for payment. Jacqueline Baker made a motion to pay the invoice. Ollie Collins seconded the motion. Motion passed 6-0.
- 10. Law Seminar Update Mrs. Baker discussed HB206. This proposal is for School Board Member elections. It would make elections every 2 years and the Board Member would only be allowed to serve for 8 years. She stated that 20 more bills were introduced the day of the Law Seminar. Mrs. Baker also discussed the information they received from the EEOC presentation. Sin, Sex, and Poor Decisions presented by Mary Young and Emily Runyun. They discussed the Code of Ethics and "Croatia your thoughts". "Croatia your thoughts" was her way of describing adapting to new things. The discussion of the Code of Ethics was to be mindful of the things that are stressed to the students and the way it's presented to the students. Teachers also should not be conversing with students on the student's phone. Everyone should also be more vigilant on reporting child abuse. Ollie Collins also brought up teachers wearing earpods or talking on their phones in class. Mr. Collins also stated that most districts are having the school attorney present at all board meetings and he thinks this is a good idea. Dr. Dedmon asked if the Board Members would like to speak with the Mixon Law Firm about coming to our meetings. Dr. Dedmon stated that at the Annual ASBA Conference it is stressed to reach out to local legislators to voice opinions on any legislation that is being presented.

11. Superintendent's Report
