- Ben Schafer presented the New Regional CTE Center. Three schools (Ray, Trenton, Grenora) would make up a joint powers agreement of participation in area center.

- Next school year Garden Valley will move to a Kindergarten thru fourthgrade Elementary School. This will help alleviate classroom size in our other elementary schools. Garden Valley will have two sections for each grade.
- Round Prairie is set to become Williston Basin School District #7's
  Newcomer Center. WBSD7 has over 400 ELL students. This model is
  similar to other class A school districts. The newcomer center will provide
  much-needed services to this student population. This center will have an
  ELL Coordinator, two teachers, and a paraprofessional.
- Bussing will be provided to students attending the Newcomer center. Dr. Faidley stated that older kids and younger kids would not be bussed together for the next school year.
- Dr. Faidley spoke on one of the agenda items that came from the Personnel & Finance agenda. The Interim carry over fund was forwarded to the policy committee to draft wording for the carry over percentage amounts to include the minimum and maximum.
