## **ADJOURN**

#### 1. GUESTS

One speaker, Austin Sauerbrei was in attendance to address the board. Chairman Brown explained that Dustin Prichard would be the official timekeeper, and Mr. Sauerbrei would have five minutes to address the board. Chairman Brown explained that when four minutes were up, Mr. Prichard would let him know he has one minute remaining.

Mr. Sauerbrei said that he and his wife moved to Athens about a year and a half ago with their two boys ages 3 and 6 and that they are part of the McMinn County Neighbors, which is a group of parents, educators and community members that work together to support local schools. He explained that he was concerned about the recent third grade retention policy that was passed by the state legislature and how it will impact kids, teachers, and staff in McMinn County. Mr. Sauerbrei said after reading the bill and looking through the newly released toolkit from the Department of Education, his understanding is that this new law will hinge third grade retention decisions on a single standardized ELA test. He said his first grade son is a pretty good student, excels at reading, loves to write stories, make art, and loves school. For one of his assessments last year in kindergarten he had to take a test on an iPad in a crowded room with all his classmates. His son got the kindergartner jitters, froze up and bombed the test and that test put him in the 17<sup>th</sup> percentile on one of the core sections. He said this test was not a fair assessment of his progress and in this case they were able to move forward and keep him on track, but this new legislation could hold back his son and thousands of other students based on a single bad day.

Mr. Sauerbrei said that many have expressed ongoing frustration with the undue weight that TCAP testing places on students and teachers. He said he won't presume this third grade retention bill was passed with ill intent, we all want our students to be learning at a level appropriate for their age and want our kids to get the extra support they need to keep on track. Mr. Sauerbrei said this legislation feels like a big step in the wrong direction at a time when our teachers and staff are in dire need of support, not to mention the long term impact that this could have on kids in our community. He said he knows that school boards, administrators, and teachers have been put in a difficult situation having to deal with the ramifications, but given that it is in the system's lap now, he has some questions.

1. Many of our teachers are stretched almost to the breaking point already. Adding in summer school, additional tutoring, and presumably a bubbling third grade student population, what are your plans to increase teacher salaries or add new staff to help fill in these gaps? If not, how can you support and advocate for the resources needed to fill in those gaps?

- 2. In the toolkit, summer camps were presented as an intervention option. Do we know if there's any evidence that the Summer Bridge programming offered will have any impact on reading comprehension?
- 3. Senator Mark White, who sponsored the bill has said we should review and make changes to the law if needed. As a local school district, what are we doing to solicit feedback from teachers on this issue, track results, and advocate at the state level?

Mr. Sauerbrei said he appreciates the board, and he doesn't presume to have answers and doesn't expect the board to have it all figured out either. He said he hopes the needs of students and teachers can be kept front and center and find constructive ways to move forward together.

Chairman Brown asked if any board member needed to pull an item from the Regular Consent Agenda to be discussed. Mike Cochran asked to pull item 2.b. Bids & Purchases for more information on the Instructure purchase.

Director Parkison explained that this is the Benchmark Software purchase, the same software that was used last school year, and the teachers were loving it. Julie Goodin said this program allows them to see what standards and what areas each student is missing and has been very receptive in our district and this gives us more data and tools in our toolbox. Steven Brady explained that this software does several things, it is used for benchmarking which is important because it helps them see how that student is progressing throughout the year.

Jonathan Pierce moved to approve the Regular Consent Agenda. Motion was seconded by Donna Casteel. Motion passed by unanimous vote.

Darren McCracken went over the yearly requirements set forth by E-Rate and discussed the mandates set forth in the Child Internet Protection Act (CIPA) and what McMinn County School District is doing to be in compliance with those mandates.

The system must enforce the use of technology protection measures. McMinn County Schools does so with an internet web filter, student content monitoring solution, and student device monitoring and safety software.

The system must have an Internet Safety Policy and an Acceptable Use Policy. McMinn County Schools adheres to Board Policy 4.406, Use of Internet and the Acceptable Use Policy is reviewed each year and is included in student handbooks and is available on McMinn County Schools system and school websites.

Schools must also educate minors with respect to online safety and cyberbullying. Typically, school counselors meet with students at various times throughout the school year and discuss the importance of being safe with their digital footprint as well as providing handouts throughout the year concerning online safety and cyberbullying.
