Behavioral Task Force / School Culture-Climate - Updates

Dr. Chesson gave an overview of the Behavioral Task Force's work.

The update on behavior included graphs with data from November calls for support by the following:

Level of calls

Gender

A mini task force was created at Florence Roche and Marla De La Cruz has been spending more time with this team to help support services. Numbers are up at Swallow Union where an outside consultant and additional support have been hired to assist the staff there. The committee was also updated on where the district stands with training on de-escalation practices.

Overall the committee questioned the use of reporting by gender and felt that not enough detail was given in the data. The next meeting for this group is in November.

The school culture-climate online survey is scheduled to pilot in the next 2 weeks. The instrument was selected and the sample questions were reviewed.

Announcement -

The school committee will be holding a workshop in January with a representative from MA Association of School Committees (MASC) coming to do some training. Topics will include the superintendent's evaluation process.

CIAA Update - Superintendent's Evaluation

The CIAA and Superintendent Chesson worked together to choose the focus of her evaluation: The focus of the evaluation will be on student learning goals, professional practice goals and district improvement goals.

If the evaluation's are not submitted by the deadline, they will not be included in the summative assessment. If, under the various categories there is an unsatisfactory or needs improvement, or proficient, each category is a point and they will be rounded up or down. 1.49 or lower the score is identified as 1; if the score is 1.5 or higher the score is identified as 2.

Categories were identified:

Std. I - Instructional Leadership

I-B - Instruction

Std. II - Management & Operations

II-A - Environment - Develops and executes effective plans, procedures, routines, and operational systems to address a full range of safety, health, emotional, and social needs.

 $II-E-Fiscal\ Systems-Develops\ a\ budget\ that\ supports\ the\ district's\ vision,\ mission,\ and\ goals;\ allocates\ and\ manages\ expenditures\ consistent\ with\ district-\ and\ school-level\ goals\ and\ available\ resources.$

Std. III - Family and Community Engagement

III-C - Communication - Engages in regular, two-way, culturally proficient communication with families and community stakeholders about student learning and performance.

Std. IV - Professional Culture
