The Beebe Board of Education met in a regular session on Monday, April 17, 2023, in the Beebe School Board Meeting Room.

### I. CALL TO ORDER

Mr. Jason Smith, President, called the meeting to order at 5:02 pm.

### II. APPROVAL OF AGENDA

Dr. Nail presented the Agenda with no changes.

### III. BOARD WORK SESSION

The Board was presented with the district's proposed 2023-2024 salary schedules

### IV. EXPULSION HEARINGS

A. The Board entered an Open Expulsion Hearing for Student Jase Miranda (Student ID# 900001510). Mr. Art Bell introduced the details of the hearing. Mr. Zeb Prothro explained the circumstances of the expulsion recommendation that the student be expelled through December 19, 2023 with a referral to the Alternative Learning Environment upon return from expulsion.. Jase's mother spoke on behalf of Jase. Evidence was viewed by the Board.

In the case of Student P.P., Clay Goff made a motion to modify the expulsion recommendation to state that the student be expelled through August 10, 2023. If deemed appropriate upon assessment by a counselor in August, the student will

enter the Alternative Learning Environment beginning August 14, 2023. Bennie Brock, Jr. seconded the motion.

The student's expulsion period will be from April 18, 2023 through August 10, 2023. The student will continue to receive educational services via an online platform. If deemed appropriate upon assessment by a counselor in August, the student will enter the Alternative Learning Environment beginning August 14, 2023.
