The Clinton City Board of Education met on April 14, 2022, in the Clinton Municipal Building. Board of Education members present were: Tim Bible, Joey Smith, Curtis Isabell, David Queener, and Lorie Wilson. Board of Education members not present: Merle Pryse. I. Call to Order by Board Chair

Chairman Bible called the meeting to order at 5:28 p.m.

II. Approve Agenda and/or Additions to the Agenda

Chairman Bible asked for approval of the agenda. A motion was made by Curtis Isabell to approve the agenda as presented, with a second by David Queener. The motion carried 5-0.

IV. Financial Report:

Approve Financial Report – March: Kelly Johnson, Director of Schools, pointed out several highlights in the report, and recommended to the School Board for approval the March Financial Report.

A. Approve 2022-2023 Salary Schedules on First and Second Reading:

B. Approve 2022-2023 Budget First Reading: Kelly Johnson reported on the 2022-2023 proposed balance budget. The General Purpose School Fund: Increase in salaries and benefits were: 1) offset by reductions in various expenditures, and 2) funded by increases in State revenues. The Federal Projects Fund: Title funds preliminary allocations and carry-forward amounts are not known at this time; conservative estimates used for program planning purposes. The Title, IDEA, and ESSER funding include: Title I, II IDEA-PreK, ESSER2.0 and ESSER 3.0. The Cafeteria Fund: Decrease in budget due to anticipated reduction in USDA support of universal-free breakfast and lunch service. The structure of food service management contract protects CCS from fluctuations in number and reimbursement category of meals served.


VIII. Adjournment of Meeting
