## <u>April 11, 2022</u>

#### Statements from the Audience

Randa Nickel, parent, addressed the board regarding the large class sizes at Union Valley Elementary School in the second grade. She and the parents of 22 other 2nd grade students met with Principal Paul Erickson last Thursday to discuss the topic and share their concerns. They would like to see an additional teacher to be hired to help alleviate the large class sizes.

## PHMS Building Report

Mrs. Abby Thompson, principal at Prairie Hills Middle School shared information about how PHMS has been working on their Goal for KESA to increase pods of interactions between stakeholders. They have had college and career opportunities with a career fair and visits to WSU Tech and Bethel College.
