Statements from the Audience

Lori Hartnett, mother of 4 children in the district, spoke to the board as a representative of several parents of the incoming third grade class at Union Valley Elementary School. Parents are concerned with the impact of the large class sizes in this grade level. They feel like there has been loss of learning due to Covid since their kindergarten year. They would like the board to consider options such as lowering class sizes by hiring an additional teacher, hiring additional para support and starting MTSS interventions for math and reading in August versus October. They would also like better communication from administration regarding changes that are being considered.

Special Recognition

The Buhler High School girls soccer team finished second at the 4-1A State Tournament. This is the best finish of any girls soccer team in Buhler soccer history. Coach Randall Rank introduced the team members who were present and acknowledged their hard work and dedication this year. He also thanked his assistant coach, Eric Stambaugh.

Ron Clark Academy

A group of 13 educators attended the Ron Clark Academy in Atlanta, Georgia at the end of May. Several of those who attended gave a report on their learning. They will return to a board meeting later in the year to report on how they have implemented what they learned in their classrooms. Service Agreement - PRENDA

- The BHS tennis courts are scheduled to be resurfaced July 1 pending weather.
- The admin is working on several grant applications including the grant for Safe and Secure Schools, Mental Health Initiative Grant and the KDHE grant.
- Congratulations again to the girls soccer team as they had a great season and represented Buhler well.
- Matt McCabe, our KSHSAA board rep, reported that at the spring KSHSAA board meeting they passed a resolution to put in a multiplier for the private schools. This now has to be voted on by schools, the State Board of Education and then finally the legislators.
- Essdack's new executive director will start on July 1.
- The district should expect to see an increase of 6 1/2 % in assessments from RCEC.
