SEMI-FORMAL ATTIRE IS REQUIRED.

- ⊗ NO jeans
- ⊗ NO sneakers
- ⊗ NO COSTUMES OR ACCESSORIES [masks – hats – canes – sunglasses or glow accessories, etc.]

LADIES

- ☑ Dress top must NOT be too revealing (no plunging neckline)
- ☑ Dress length should not be higher than 2 inches above the knee
- ☑ Backless dresses may NOT be lower than the waistline
- ☑ Dresses must not have a slit that exceeds mid-thigh (fingertip length)
- ☑ Midriff MUST be covered
- ☑ Dresses with openings on the sides of the midriff are not permitted

GENTLEMEN

- ☑ Only dress shirt with tie/bow tie and dress pants are acceptable
- ☑ Jackets and suits can be worn but are not mandatory
- ☑ Pants must have a belt and cannot sag below the waist line
- ☑ Dress shoes are required. NO tennis shoes or sneakers.
