### STUDENT DRIVERS

Student Parking Permit (REQUIRED for all student drivers)

**All students with a valid Virginia Driver's License only:** With a valid driver's license issued to the student, a parking permit can be issued at Open House.

After the Open House Nights, completed applications may be returned to **Mrs. Alger** in the main office beginning **August 11<sup>th</sup> (between 8 a.m. and 4:00 p.m.)** for issuance of parking hang tags. All students with a valid driver's license **MUST** register their cars by the end of September. Vehicles parked on campus without proper parking permits may be towed at the owner's expense.

### PARENT PORTAL

Parents have an opportunity to access Parent Portal, an internet based program that allows parents to view information such as their child's attendance and grades. Student records are updated in real time so this will be the most up-to-date method for obtaining information regarding the progress of your child. The portal also provides a parent-to-teacher email option for obtaining answers to quick, simple questions. This method of communication is intended to supplement, not replace, current modes of communication used by teachers, parents, and students.

Due to security and confidentiality requirements, parents will have to personally visit the school to pick up their password. Please plan to bring a picture I.D. (driver's license) to verify your identity.

Additionally, PCHS will only be able to provide the option to individuals who have legal access to a particular student's records. One Parent Portal account will be available per student. We are excited to offer parents this additional opportunity and hope that the parent portal will provide a convenient and easy way for parents to monitor their son/daughter's daily progress.

## **STUDENT DEMOGRAPHIC INFORMATION**

Contact with our students' families is imperative for success, and having correct contact information is essential. Included in this packet is a demographic sheet to update student information. Valuable information is sent to parents and students several times per year. Also, automated telephone calls are made regarding attendance, SOLs and other pertinent announcements. It is the responsibility of the parent/guardian to contact the PCHS school counseling office or data office to correct information following a change of residence or mailing address and phone numbers. Changes in legal information must be presented to the Registrar in person and a copy of the change placed in the student's cumulative record. You can reach either of these offices at 643-0360 or 643-0275 between the hours of 8:00 a.m.-4:30 p.m.

## **DRIVER EDUCATION**

This school year, all 10th grade students will receive the 36-hour class phase of driver education as an integral part of P.E. 10. The behind-the-wheel phase will be a 14-hour experience (seven hours driving experience and seven hours in-car observation) and will be conducted outside of school hours at a cost of **\$209**.

## **SCHOOL SUPPLIES**

Information regarding needed supplies for this semester's courses will be provided by teachers during your student's first day of school as needs will vary amongst courses.

## **BREAKFAST & LUNCH**

All PCPS students will be provided the opportunity to take both a breakfast and lunch through Community Eligibility Provision (CEP). Breakfast will be available upon arrival each day, and lunch will be served in your student's third block classroom each day. Students will be given the opportunity to submit their lunch confirmation each day via email.

## **All Sports Pass**

The All Sports Pass for the 2022-2023 school year will be available at the following prices:

Individual Student: \$50

Individual Adult: \$75

This pass will grant admission to all fall, winter, and spring home contests (excluding benefit games, district tournaments, and state playoffs). This is a great money saving option for PCHS Sports Fans. The All Sports Passes will go on sale Monday, August 15, 2022 in the PCHS front office. The passes will also be available for purchase at the PCHS Open House Night..

## **Health Notes**

Every student must turn in a completed Health Information Form, to the nurse, within the first 14 days of every school year.

Upcoming Seniors must provide documentation of a meningitis vaccination, per the updated state requirements, prior to the first day of school. No senior may attend school until this documentation has been provided to the school nurse.

No student may carry or have medication in the clinic without an order signed by a physician and the parent. A Medication Authorization Form, Allergy Care Plan, Seizure Care Plan, Diabetes Care Plan, and Asthma Care Plan can be found on our school website or picked up at the main office.

Please contact your school nurse if you have questions or concerns.

## PARKING EXPECTATIONS

1. Any classmen with a valid driver's license may apply for a parking permit.
2. All financial obligations to the school must be cleared before a student parking permit may be issued.
3. Vehicles should be locked during the school day. The school is not responsible for property stolen from any vehicle parked on campus.
4. Enter and leave school grounds in a safe manner. The speed limit on school grounds is 10 MPH.
5. Get out of your vehicle immediately after you park and leave the parking lot. Students may not return to the parking lot during the day without a pass from an administrator.
6. Any changes in license numbers or vehicles must be reported to Ms. Alger.
7. The privilege to park on school grounds may be suspended if a student driver has excessive tardies to school, and/or fails to maintain good attendance and behavior, and/or is involved in skipping a class or school. A driver who takes other students off campus illegally is considered involved in skipping and will be subject to disciplinary measures that include the loss of driving privileges.
8. The student also accepts the responsibility to observe all regulations pertaining to student drivers contained in the Student Handbook.
9. Students may park in ASSIGNED student parking spaces only, which are designated in the GYM lots. Student parking along curbs, teacher lots, CTE lots on school grounds is strictly forbidden.
10. Students who park their car on school property after their privilege to drive to school has been revoked will have their cars towed at the students' expense.
11. All students with a valid driver's license, who plan to park on PCHS property, must have their vehicles registered with PCHS by September 30. The parking tag must be displayed on the vehicle at all times or it will be considered illegally parked and subject to be towed at the owner's expense. Students who lose their parking tag will be charged \$5.00 for a new parking tag.
12. Students who have early release passes must leave the parking area within five (5) minutes after their release from class.
13. Student drivers are to abide by the campus rules and also need to be aware that school personnel and/or law enforcement officials can search their vehicles. Also, legal action can be taken relative to search and seizure of any contraband or weapons.
14. Student parking is first come first serve. Senior parking is noted by a red square and honors parking is noted by a yellow square. All Seniors will be issued a Senior Parking Pass. If a student arrives after the Senior parking lot is full, they will park in the overflow parking in the lower lot. Any honors student arriving after the honors parking lot is full, they will park in the overflow parking in the lower lot.
15. Parking tags are not to be shared with other drivers.

## PENALTIES FOR PARKING VIOLATIONS

- First offense – Loss of driving privileges for 5 school days
- Second offense – Loss of driving privileges for 10 school days
- Third offense – Loss of driving privileges for 20 school days
- Fourth offense – Loss of driving privileges for the remainder of the school year

**ADDITIONAL INFORMATION**

**Teen Driving Restrictions**

Virginia's driving restrictions are not meant to penalize teen drivers, but to help them stay safe while they gain valuable driving experience. Studies have found that these restrictions work to reduce the number of car crashes among young drivers.

**Curfew Restrictions**

If you are under age 18, Virginia law prohibits you from driving between midnight and 4 A.M. except when driving:

- to or from a place of business where you are employed;
- to or from an activity that is supervised by an adult and is sponsored by a school or by a civic, religious, or public organization;
- with a licensed spouse age 18 or older, parent or other adult acting in loco parentis who is occupying the front passenger seat,
- in case of an emergency, including responding to emergency calls as a volunteer firefighter or rescue squad personnel.

**Restrictions on the Number of Passengers**

**If you are under age 18**, you may carry only one passenger under age 21, unless accompanied by a licensed parent, or other adult acting in place of a parent, in the front passenger seat. However, after you have held your license for one year, you may carry up to three passengers under age 21 in the following situations:

- Travel to and from a school-sponsored activity;
- A licensed driver 21 or older is in the front passenger seat; or
- In case of an emergency.

Learner's permit holders may not carry more than one passenger under age 18.  
(Passenger restrictions do not apply to family members)

**Cellular Telephone Restrictions**

**§ 46.2-818.2.** Virginia's cellular telephone law prohibits any person from holding a handheld personal communications device while driving a moving motor vehicle on the highways in the Commonwealth.
