Cell Phone Policy

- 8th grade students are only allowed to use cell phones during lunch. 9th grade students are only allowed to use cell phones during lunch and in the hallways. During instructional time, cell phones should be turned off and out of sight in their lockers.
- Students are prohibited from using cell phones or other electronic devices to capture, record, or transmit audio, video, or images of any student, staff member, or other person in the school or while attending a school-related activity, without express prior notice and explicit consent from administration. Phones cannot be used in any situation where a reasonable expectation of privacy exists. These locations and circumstances include but are not limited to locker rooms, shower facilities, restrooms, and any other areas where students or others may change clothes.
- Unauthorized use of cell phones will result in confiscation of the cell phone. Confiscated phones will be turned into the office. Repeated violations of possessing a cell phone at inappropriate times will result in disciplinary action. If a cell phone is confiscated, a parent or guardian will be required to pick up the cell phone from school.

Dress Code Summary

Dress and grooming for the students of Marietta High School is an individual matter as long as common rules of health, safety, and decency are maintained. Styles and the names of articles of clothing change frequently. Therefore, it is impossible to list all inappropriate items. The following guidelines should be followed at all times within Marietta High School facilities.

- All tops MUST cover both shoulders and chest.
- All tops MUST be long enough to be tucked in, if asked to do so.
- Hats, toboggans, visors, cloth sweatbands, and scarves/bandannas are unacceptable headwear for males and females. Hoodies may be worn if the hood of the sweatshirt is not on your head inside the building. During school headwear may be confiscated for the remainder of the day or longer.
- Any language or patterns of clothing MUST be socially acceptable. Language and/or patterns should not be vulgar, profane, or suggestive of drug or alcoholic usage or other illegal activities.
- Clothing may not be excessively torn, revealing or excessively baggy. Undergarments must not show. See-through or mesh garments must not be worn without appropriate coverage underneath.
- The administration of Marietta High School reserves the right to have the final say in all student attire issues! Failure to comply with the Dress Code guidelines is an insubordinate act and will be treated as such.

Athletic Eligibility

- Student athletes (grades 7-12) must have a minimum 2.0 GPA during the immediately preceding nine-week grading period to be eligible to participate in interscholastic extracurricular activities.
- The Marietta Board of Education and the Marietta High School Athletic Department have instituted a tutoring program for athletes who may fall below the 2.0 GPA requirement. If the student-athlete follows the tutoring guidelines, he/she will be eligible to play in all games during the nine-week grading period in which the tutoring occurs.
- For 7th grade student-athletes the minimum is passing FOUR classes. Failure to follow these guidelines will result in a loss of eligibility for participation during the succeeding nine-week grading period. All 7th grade students are eligible for athletics the first nine weeks.

MHS School Lunch and Program

Marietta City School District has selected the PaySchools Payment Portal for parents to monitor, pay lunch accounts and to complete the online free and reduced lunch application. The free/reduced application must be submitted online to qualify for free/reduced meals and school fee waivers for households who qualify.

Meal Cost:

\$1.95----- Entree

\$3.25 ----- Meal

\$0.75----- Milk

MHS is a pilot program for the free/reduced lunch program. Anyone qualifying for reduced lunches gets lunch for free this year.

Process:

1. Families will need to create a free account through PaySchools
2. Email will be sent to the email identified- parents will need to confirm email and create a password to finalize the PaySchools Account.
3. Once an account has been created- parents/guardians will need to answer the following questions - Security Questions to help recover your account, questions to add your child and payment information (if you wish to make online payments to the AVI lunch program) this only applies if you do not qualify for free/reduced lunch.
4. Please note- when adding a student, please verify student district ID number- this is identified under the Student Number in Infinite Campus or this is the lunch number that students use to grab their lunch
5. Once your child has been added- please go to the right hand side to complete the free & reduced lunch application- this will indicate if you qualify for a waiver for lunch and student fees.
6. Please be reminded that families must go through this process annually to verify qualification status.

Dear Parent or Guardian:

Your child's School District is excited to partner with *Vision To Learn* and to provide vision services to students. This includes a vision screening, routine eye exam and, if needed, eyeglasses.

All this is available at no cost to you.

About *Vision To Learn*

Vision To Learn is a non-profit organization working in communities across the U.S. offering vision services to students in support of their academic achievement.

Student Vision Services

Vision screenings will take place at your student's school. If your child does not pass the screening, they will be referred to the *iSee with Vision To Learn* mobile clinic to receive a routine eye exam from an independent licensed optometrist. If needed, your child may also be prescribed glasses. The optometrist will also notify you if your student needs follow-up eye care.

iSee with Vision To Learn follows CDC, state and federal regulations including staff daily health screenings, the use of Personal Protective Equipment for staff and students, and thorough disinfection between patients. *iSee with Vision To Learn* is committed to following best practices to prioritize the safety of our students.

Student Information for Vision Services

The District will share your child's name, date of birth, gender, parent/guardian name, demographic and contact information, and vision screening results with *iSee with Vision To Learn*. *iSee with Vision To Learn* will share your child's eye exam information with the District. *iSee with Vision To Learn* may also share limited information required to receive programmatic funding from the state.

Medicaid Benefit Usage

Receiving vision services provided by this program will constitute a routine eye exam and – as needed – eyeglasses and dispensing of glasses that may be billed to your child's Medicaid benefits, if applicable. Please note that a no-cost eye exam and eyeglasses will be provided even if your insurance cannot be billed. You may receive a notice called an Explanation of Benefits (EOB) from your insurance carrier with information regarding the services billed and the payments that have been approved, but you will not receive any bill for the services or eyeglasses.

Glasses

If your child receives a prescription for glasses:

- 1) They will choose a frame.
- 2) *iSee with Vision To Learn* will order the glasses.
- 3) A trained and licensed optician will dispense the glasses at the school within 2-3 weeks.
