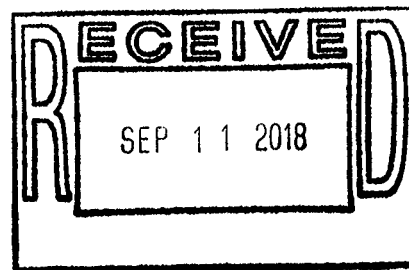
I am specifically not asking for any student specific information that would identify a particular student. You may redact anything made confidential by law.
