7.1 Approve request to temporarily suspend SSD3 Policy 3311

Shane Quick motioned to open agenda item 7.1, Alex Conrow seconded the motion; Mr. Chris Clairmont asked for permission to bring Ron Anderson into Superior Schools for the express purpose of a historical presentation about the lives of mountain men in Montana. Part of the presentation includes firearms that were prevalent in early Montana history and the ball & cap weapons, these will have their firing capability disabled. The presentation will take place on Monday, December 19 during third, fourth and fifth periods. The suspension of this policy request will terminate at 3pm Monday afternoon. Mr. Kinney recommended that the Board approve the request to temporary suspend SSD3 Policy 3311 on Monday, December 19 as presented, all in favor, motion carries 4-0

7.2 Approve eligibility language revision to high school activities & student handbooks

Alex Conrow motioned to open agenda item 7.2, Shane Quick seconded the motion; Mr. Labbe would like to revise eligibility language in the high school activity and student handbooks to ensure that students are making adequate academic progress each week prior to participation in competitive extracurricular events. 7.3 Approve wrestling cooperative request with St. Regis School District

Alex Conrow motioned to open agenda item 7.3, Shane Quick seconded the motion; Ms. Jess Nagy has been asked by St. Regis School District to enter into a cooperative activities' agreement application to the MHSA for the sport of Wrestling for the 2023-2024 school year. This cooperative agreement will run for three (3) consecutive years and may be extended in three-year intervals thereafter through application to the MHSA. Mr. Kinney recommended that the Board approve the cooperative agreement request as presented, all in favor, **motion carries 4-0**
