The health and safety of the students, staff, and our community is a top priority of the Salisbury-Elk Lick School District. The school board and our school pandemic Team continue to make decisions in response to the ongoing challenge of Covid-19 utilizing the best resources available.

In response to the expiration of statewide mitigation orders, the Salisbury-Elk Lick School District has identified organizational standards and expectations which outline the protocols and procedures expected of all students and staff members. These include the following:

- Self-screening for COVID-19 symptoms
- Following communicable disease reporting procedures
- Practicing hand hygiene and respiratory etiquette Optional use of face coverings / adherence to health and safety plans of locations served
- Cleaning and disinfecting as revised by new protocols.
- Staying informed of CDC's guidance relative to travel
- Monitoring communication and confidentiality
- Participating in required training (current employees as well as new hires as part of their onboarding process)
- Staying informed and maintaining best practices Expectations are based on the latest mandates issued by the Governor's Office, the Pennsylvania Department of Health (DOH), the Pennsylvania Department of Education (PDE), the Department of Human Services (DHS), and the Centers for Disease Control and Prevention (CDC)
- The Administrative Team and Pandemic Team will continue to monitor communications. As conditions change related to COVID-19, protocols are subject to change.

Any students in grades K-12, will have the option of choosing to be a virtual learner or an in-person learner. The district has purchased technology for all students. If a student wants to be a virtual learner, they will be enrolled in the Extended Campus Virtual Learning School. If families need a hot spot for internet, the district will provide one. The district has also used funding to purchase social emotional learning programming available to all students and staff. We are also implementing a schoolwide Catalyst Action Team. The district also offers breakfast and lunch to all learners as outlined in our food service program.

Universal and correct wearing of masks;	cDC guidelines as of February 22, 2022 implementation: Salisbury Elk Lick School District implemented and will continue to follow the Center for Disease Control and Prevention guidelines for masking. Masking is not recommended in schools and early education settings in areas with low or medium COVID – 19 risk. The recommendations may be changed due to increase of cases in our area. Students may voluntarily wear masks and parent must provide masks for their child.
	According to the CDC's website, "effective February 25, 2022, CDC does not require wearing of masks on buses or vans operated by the public or private school systems, including early care and education/childcare programs." Any student or staff member may voluntarily wear a mask.

	a dedicated custodian for disinfecting throughout the day per protocol. The district will maintain a schedule and seating patterns that have been effective in prevention of transmission of Covid.
c. Handwashing and respiratory etiquette;	Handwashing/Sanitizer use – upon arrival and departure from school, before eating, after play, after sneezing. Display signs. Washing hands/disinfecting hands in between each class change
d. Cleaning and maintaining healthy facilities, including improving ventilation;	Cleaning, sanitizing and disinfecting will be a daily routine in the District as per protocol. This includes the cleaning, disinfecting and sanitizing of surfaces, classrooms, restrooms, fountains, and transportation vehicles. A first aid/medication station inside the Nurse's Office, with separation, is available to provide services. Ventilation – all units in classrooms and offices have fresh air intake capabilities, windows/doors open in classrooms, fans and air purifiers as needed and recommended.
e. Contact tracing in combination with isolation and quarantine, in collaboration with the State and local health departments;	A student or staff member who is diagnosed positive for COVID will isolate for five days from the onset of symptoms. Household contacts will remain home for 24 hours unless they are fully vaccinated. COVID testing will be offered with parent permissions to rule out infection of asymptomatic individuals. SELSD reserves the right to impose all restrictions if the COVID case rate increases to the "high" category.
f. <u>Diagnostic</u> and screening testing;	The Test to Stay COVID testing has been suspended. If symptoms develop or

g.	Efforts to provide vaccinations to school communities;	SELSD will continue to collaborate with local health care providers and communicate with all students, staff, and community opportunities available for vaccines.

SELSD will continue to maintain and seek out additional partnerships with local and state agencies to assist us in our efforts to maintain a healthy and safe educational environment and to educate our students, staff, and community as best we can with regards to Covid-19 and any other health related concerns. The district will adhere to reporting mandates and submit aggregate case numbers to the PA DOH on a weekly basis using the Future Ready Comprehensive Planning Portal.
