Motion by Dittmer, support by Becker, that the West Shore ESD Board of Education approve the 2022-2023 Cost of Living Allowance of 2.17% plus a 2% off-schedule Attraction & Retention stipend to the Administrators and AASG salary structures, and the WSEA and AFSCME collective bargaining unit pay schedules as presented.

Great Start Readiness Program

Motion by Becker, support by Chancellor, that the West Shore ESD Board of Education adopt the Great Start Readiness Program pay scales as presented, not to exceed \$93,388 in FY2022/23. Motion carried 4-0, 3 absent.
