

*This form is required of students who are planning to enroll through the Southeastern McCurtain County Campus. Either Eastern Oklahoma State College or Southeastern Oklahoma State University offers classes at the Idabel location.*

To be eligible for concurrent admission, a high school student must have participated in the ACT and meet one of the following requirements:

**EOSC Requirements**  
 ACT Composite score of 19 OR  
 3.00 GPA

**SE Requirements**  
 ACT Composite score of 20 OR  
 3.00 GPA & top 50% class rank

A new **Concurrent Student Permission Form** is required each semester of concurrent enrollment. To be eligible for pre-enrollment, concurrent students who are currently enrolled must provide this **form** for the requested semester of enrollment, a **current high school transcript, ACT score report, and class schedule**. If the concurrent student fails to maintain a 2.00 GPA for the enrolled semester, they will no longer be eligible for concurrent enrollment and their pre-enrollment for the next semester as a concurrent student will be cancelled.
