#### 6. Superintendent's Update:

- a. Bond Update. Mrs. McKinney and Derek Zongker met with Sid Wiens and Doug Anderson regarding the October 1st completion date. Also discussed was the fact that the fire marshal is requesting that there be more than one fire hydrant on campus after he had approved only having one. The district may have to apply for a variance.
- b. Substitute Teacher Pay. Example letter with pay amounts included in packet. Mrs. McKinney is recommending to increase pay amounts by \$5 for all three steps.
- Steven Westfahl and Eric Geesling moved and seconded the approval of \$10 for the three steps now making the pay \$95 per day, \$100 per day after five consecutive days and \$110 per day after fifteen consecutive days. Motion carried 6-0.
- c. <u>Daycare handbook</u>. Handbook was handed out to BOE members. Daycare Director, Katelynn Tiemeyer suggested additions to the handbook. Daycare fees will be prepaid before child care will be provided. It will close during the summer. No drop-ins will be accepted. A fire door is required. Aaron Basye, Maintenance Director will do the work. The door will cost \$2,000.
