6. Presentations

- Monica Apodaca gave an update on the pilot and adoption process for History/SS Adoption for Grades 6-8. She described the four distinct phases which are: review, pilot, adoption, and implementation. Publisher training for teachers will begin in January 2023.
- Kelly Davids shared the Master Plan for Multilingual Support which provides specific guidance for all district and school staff on how to identify and serve multilingual learners. District expectations are provided for program implementation and are the foundation for accountability in the delivery of MLL program services.
- Pam Allaway shared information about the district's core ELA/ELD programs
 and implementation for our students. <u>Wonders</u> is used for grades K-5 and
 <u>Study Sync</u> is used for grades 6-8. These provide targeted ELD instruction
 and instructional materials for emerging, expanding, and bridging-level
 students. She also described information on the supplemental program called
 Imagine Learning. This program is used by students as an independent
 activity. Teachers are able to monitor the student progress.
