ACE Program Eligibility and Possible Fees:

- Students who qualify to participate based solely on their status as an English learner are eligible for a reduced-fee program.
- Students meeting eligibility requirements for the Federal Free and Reduced Meal Program may participate in ACE at no cost.
 - Families must complete the Federal Free and Reduced Meal Program form annually to ensure eligibility. This form will be available July 2023.
- Families enrolled in a Subsidized Program may not concurrently participate in the ACE program.
- Eligibility for the ACE program is subject to change. Families who become ineligible will be notified and a 2-week transition period will be provided. Families will have the option of maintaining their child's enrollment in the Child Care program by transitioning to a fee-based account (see Child Care Contract for rate details).
- For ACE families in the no cost program: On school days the ACE program extends the school day until 5:00 PM (Grade 6) or 5:15 PM (Grades TK-5). Families of children picked up after this time more than five (5) times throughout an academic year, will be added to a fee-based contract to support the additional time the student is in attendance.
- For ACE families in the no cost program: On intercession/summer session days the ACE program operates from 8:15 AM to 5:15 PM. Families of children picked up after this time will be charged a \$20.00 fee per child, per day which must be paid on the next program day in order for the chil(ren) to continue program participation.
