Closed Session (5:45 pm) Regular Meeting (7:00 p.m.)

The Regular Meeting of the King & Queen School Board was held on Wednesday, April 20, 2022 at 7:00 p.m. in the CHS Auditorium. The Closed Session preceded the meeting in the CHS Library at 5:45 p.m.

Celestine Gaines, Board Chair, called the meeting to order at 5:45 p.m. The following members were present as indicated by roll call:

Closed Session

Ms. Gaines called for a motion to enter into closed session at 5:45 p.m. Mr. Hill moved to enter into Closed Session to discuss under Subsection (A) (1) Personnel Recommendations and (A) (2) Discipline. Mrs. Amos seconded the motion. The motion carried as indicated by voice vote; 5 ayes, 0 nays.

Reconvene to Open Session in the Auditorium.

At 7:05 p.m., Ms. Gaines called for a motion to reconvene to open session. Mr. Hill so moved and Mrs. Amos seconded. The voice vote was as follows; 5 ayes, 0 nays.

Ms. Gaines asked for a motion to certify Closed Session. Mr. Hill so moved. Ms. Gaines read the following:

NOW, THEREFORE BE IT RESOLVED that the King and Queen School Board hereby certifies that to the best of each member's knowledge, (a) any public business matters lawfully exempted from open meeting requirements under FOIA and (b) only such business matters as were identified in the motion by which the closed meeting was convened were heard, discussed, or considered in the meeting.

Ms. Gaines asked for a second. Mrs. Amos seconded the motion. The unanimous voice vote approved the motion to certify; 5 ayes, 0 nays.

Ms. Gaines asked the Board Clerk to certify closed session. Roll Call to certify was as follows: Amos; Certify Gaines; Certify Hall; Certify Hill; Certify Lee; Certify

Ms. Gaines asked if there were any motions from Closed Session.

Dr. Carter called Dr. Rob Wright forward to present the Elementary Program of Studies. The updates include: the new Science Standards; Information on the Student Growth Assessments; Advanced coursework at the High School under Gifted Education; and an explanation on Access to the Parent Portal.

Dr. Carter called on Mr. David Copsmith to inform the Board about the Track Restoration and KQES Renovation Update. Mr. Copsmith showed pictures on the screen of the grating, etc. on the track, and the layout for the different events on the track field. He shared that upgrading the drainage had been completed. He showed the floor plan of the current King and Queen Elementary School and reported that students will likely be in the current school building for one more year.

1st place winner. Oakley Reifsnider was introduced to the Board and to the audience. He was presented a framed picture of his work.

The King and Queen County Public Schools division 'Helping Hands Award' was presented to Ms. Anne Kennedy.
